## Diamond Advantage® Card Holder Agreement

The Diamond Advantage Card is issued by and credit is extended by Multi Service Corporation, P.O. Box 10922, Shawnee Mission, KS 66225. Any indications in this agreement to Diamond Advantage refer to Multi Service Corporation (MSC).

The holder of the Card represents that the Card will only be used to obtain business or commercial credit.

Usage of the Diamond Advantage Card by the Card Holder named on it constitutes acceptance of the following terms and conditions, as may be amended from time to time. "Usage... by the Card Holder..." includes the retention or use of the Card by the Card Holder as named on it or anyone under his/her/its control. The Holder of the credit card is liable for any unauthorized uses of the credit card and the Holder agrees to be responsible for any unauthorized use.

A credit line will be assigned to your account. This line includes all unpaid purchases, whether billed or unbilled. If, as you use your card, you find your credit line to be inadequate, please let us know.

Statements will be mailed bi-weekly and your payment is due within 20 days of the statement date. Statements outstanding more than 23 days are considered delinquent. Delinquent accounts will be assessed a finance charge at a weekly rate of 3/8 of 1 percent.

You may pay your Diamond Advantage Card by check or Electronic Funds Transfer (EFT), authorizing MSC to automatically deduct funds from your chosen bank account. Please notify us if you choose the convenience of paying by EFT.

If your bank should fail to honor payment to MSC or your account becomes delinquent, MSC may require immediate and full payment of all outstanding amounts, as well as the return of your Diamond Advantage Cards. MSC neither sells nor warrants the goods or service obtained from the International® dealers.

This agreement will be governed by the laws of the state of Missouri and it is agreed that jurisdiction of any legal action connected with this Agreement shall lie exclusively in the state or federal courts located in the state of Missouri. Notwithstanding the foregoing, MSC may, at its option, choose to pursue legal action against the Card Holder in any state in which the Card Holder does business or where jurisdiction may otherwise be proper.

In the event of the Card Holder's breach or default under the terms of this Agreement, the Card Holder will be liable to MSC for all costs and expenses, including late charges and reasonable attorney's fees or other costs of collection, incurred by MSC in enforcing its rights hereunder. The Card Holder agrees that in the event of default in payment, MSC may institute suit against the Card Holder in the aforesaid courts, regardless of where the Card Holder is geographically located or does business.

Either you or MSC may terminate this Agreement at any time. Once the Agreement is terminated, you must return to MSC all cards in your possession or control. Payment of all outstanding amounts must be made upon termination.

If Cards are lost or stolen, it is the Card Holder's responsibility to call MSC immediately to prevent unauthorized usage. Call 1-888-678-0550 to report lost or stolen Cards.
